

- b) My Child(ren) is/are in excellent health and physical condition and has/have no medical, psychological, physical or mental condition(s) except as fully disclosed on the schedule attached to this Registration Form Agreement.
- c) My Child(ren) has/have no contagious, infectious or communicable diseases and, in the event that my Child(ren) become(s) sick with any such disease after a visit to Hour Kidz during the gestation period, I undertake and agree to notify Hour Kidz of the matter immediately.
- d) If my Child(ren) should become ill while at Hour Kidz, he/she/they will be isolated from the other children present, and placed on a cot until released into his/her/their parent's care.

5. Medical Procedures:

- a) General Medical Guidelines/Discretion: Although Hour Kidz strives to provide a safe environment; it is possible that my Child(ren) could become injured. In such an event, I authorize Hour Kidz to follow its internal procedures and guidelines, including the provision of simple first aid as reasonably appropriate; however, I understand that Hour Kidz shall not be required to strictly follow such procedures and guidelines when, in the judgment of Hour Kidz, the existing circumstances require a different course of action.
- b) Medical Authorization: In the event that Hour Kidz determines that emergency medical attention is necessary for my/our Child(ren), Hour Kidz is authorized by me or whomever signs my Child(ren) in for that day, to act as an agent for me and to give my permission for my Child(ren) to be attended by a physician in such circumstances as Hour Kidz deems necessary. This includes transportation by an ambulance to a local hospital. The Child(ren)'s records will be sent with the Child(ren).
- c) Safety/Indemnity: I agree that Hour Kidz may take any action which it considers prudent to protect the safety of my Child(ren), and other children visiting Hour Kidz. I further agree to indemnify, defend and hold Hour Kidz (and its Officers, Directors, Agents and Employees) harmless from and against all actions, claims or liability, including attorney fees and court costs, directly or indirectly caused by my Child(ren) or resulting from any inaccuracy or omission made by me in completing the Registration Form.

6. State of Michigan Licensing Requirements: The State of Michigan Department of Human Services Office of Children and Adult Licensing shall have the right to enter and inspect the premises unannounced, and have access to children's records, as well as the authority to contact staff, parents and relatives of children in care, or other witnesses. The Administrator of Hour Kidz and Hour Kidz employees are required, under the Child Protection Law, to report their suspicions of child abuse or neglect to the local public children's services agency.

7. Additional Requirements: As a condition of my use of Hour Kidz, I have accurately completed and signed the Registration Form Agreement and attached Release. I understand that Hour Kidz will rely on this information when caring for my Child(ren).

8. I agree to pay all costs and attorney fees arising out of any action relating to this Agreement, or the attached Release for collection purposes or otherwise.
